Important Notes:

- Diabetes Clinic provides care for children and adults up to the age of 21 yrs. with insulin dependent and non-insulin dependent diabetes.
- Pediatric Diabetes Center accepts all insurances.
- Commercial Insurance patients (PPO/HMO) codes that are required for initial consult are 99245, 81003, 82962, 83036, and 97802 x 4.
- Commercial Insurance patients (PPO/HMO) codes that are required for follow up visit are 99215, 81003, 82962, 83036, and 97803 x 4.
- Commercial insurance authorizations must be approved to Loma Linda University Children's
 Hospital Tax ID 46-3214504 POS: 11: Office. *When procuring for private authorizations please fax
 to PCP and/or medical group for approvals.
- Commercial Insurance patients (PPO/HMO) If any of the required CPT codes are denied or not a
 covered benefit send a CRM to the clinic using Department: CHFMO PEDS DIABETES Topic: Other
 and Subtopic: Clinic Notification and Task CRM to ROUTE TO CHFMO DIABETES CRM NURSE POOL 24HRS. Also approve referral with Modifications and document a referral note identifying which
 codes were not authorized.
- Patients can use an Endocrinology SAR as long as it is an SCG02 SAR for this clinic.
- When procuring for a CCS SAR please request SAR for Center Number 7.09.07B Endocrine Center.
- When procuring for a CCS SAR and you are faxing in the request you must select Loma Linda
 Children's Hospital NPI # 1366866345 on our fax coversheet. (CCS- LA requires their own fax cover sheet and cannot be used with Financial Services fax cover sheet.)
- If CCS is closed still submit when noted. Usually it is a family that has not been seen or might have had a lapse in Medi-Cal coverage.
- When a SAR is approved for an evaluation only please document this in the referral note.
- Always check patients chart and CCS web for an active SAR (under media tab).
- Pediatric Diabetes Center Clinic schedule and cancel their own appointments.
- Always check the appointment notes, or provider tab to identify if it's an RN Class or RD class.
 These codes are only for private insurances and IEHP.
